MEASURES IMPLEMENTED BY THE SLOVAK REPUBLIC IN ORDER TO MAINTAIN EMPLOYMENT RATE IN ECONOMY AFFECTED BY THE GLOBAL EPIDEMIC.

In the first half of the week beginning on 30 March 2020, the Slovak Parliament will be presented a proposal for the largest financial aid for the Slovak economy in its short history. All the measures specified below will be suggested for adoption in accelerated proceedings. Costs for the state will amount to EUR 1 billion per month Furthermore, it is necessary to add assumption of guarantees towards banks in the amount of EUR 500 million.

Overview of measures:

1. The state will pay 80 percent of employee salaries to companies whose establishments had to be compulsorily closed.

 Contributions to self-employed persons and employees based on drop in revenue. Drop by 20 percent – EUR 180. Drop by 40 percent – EUR 300. Drop by 60 percent – EUR 420. Drop by 80 percent – EUR 540.

3. Provision of bank guarantees amounting to EUR 500 million per month.

4. Employees in quarantine and parents on care-giver's allowance will be provided 55 percent of their gross salary for the entire period.

5. In case of a drop in revenue by more than 40 percent, payments of employee's contributions can be postponed.

6. In case of a drop in revenue by more than 40 percent, advance payment of income tax can be postponed.

7. Option to apply any tax loss not applied so far, from 2014 on.
